Are you looking to hunt during the rut or off rut. If you would like to hunt during the rut which is considered a trophy hunt you can usually expect a three to ten year wait to draw depending on the species. If you are looking to hunt off the rut you can usually expect to get drawn every year to two years. Arizona is a draw state so there are no guarantees of drawing a tag with the time frames represented, and all species vary odds greatly especially big horn sheep and buffalo.

NOTES:

1. Service fees are payable with application. There will be a fee of \$25 for the first species, and for each additional species the service fee is free.
2. Bonus point fees are payable with application and are **non-refundable**. This fee will only apply if you desire to purchase a bonus point and only a bonus point. Also remember if you are only wanting to purchase a bonus point you must also purchase a hunting license.
3. License fees are payable with application and are non-refundable. This fee is for the purchase of a hunting license through the AZ Game and Fish Department. A hunting license must be purchased when applying for big game draws.
4. Tag fees are payable with application and are refundable if not drawn. If you are not drawn there will be a \$7.50 processing fee taken from the refundable amount. This fee is charged by AZGFD for application processing.
5. The application deadline shown is the Arizona Game & Fish deadline. Game Trails must receive your paper work thirty (30) days prior to AZGFD deadline date listed above. This thirty days is requested for processing purposes. Game Trails Outfitter & Guide Services, LLC. will not process and will return all paper work and fees to the client if paperwork and fees have not been received five (5) days prior to the AZGFD deadline dates listed above. **(Please do not wait until the last minute)**
6. Application service does not require applicant to book their hunt with Game Trails Outfitter & Guide Services, LLC.. Although all of our staff are highly skilled hunters, and are extremely knowledgeable of all Arizona hunt units. All fees listed above are specified for draw hunts only, and do not apply to governors tags or special hunt tags ie., supper raffle, FNAWS, SCI, etc.

Game Trails Outfitter & Guide Services will not be held liable for tags not drawn due to inaccuracies in information submitted to Game Trails Outfitter & Guide Services, or not drawn due to AZGFD regulations.
